



Notice of Race

Contender Open Meeting

Broadstairs Sailing Club

Saturday 24th & Sunday 25th September 2022

The Organising Authority will be Broadstairs Sailing Club

Racing will be governed by the rules as defined in the Racing Rules of Sailing 2021-2024, RYA Prescriptions, Class Association Rules, RYA Appendix 'S' Standard Sailing Instructions and Broadstairs Sailing Club Supplementary Sailing Instructions. The Exoneration Penalty (and the Advisory Hearing and RYA Arbitration) of the RYA Rules Dispute Procedures will be available.

'Competitors should note that the Broadstairs Sailing Club implements the RYA Racing Charter and that they will be expected to sail in compliance with it. The Charter can be found at the front of the RYA edition of the Racing Rules of Sailing 2021-2024 (the yellow pages after the definitions), or on the RYA website at www.rya.org.uk/racingrules'

The event is open to all boats of the Contender Class

Boats may enter by completing the entry form, which can be found by following the link on the BSC website, and paying the required entry fee to Broadstairs Sailing Club.

Entries will also be accepted on the day of the event

The entry fee will be £30.00

There will be 6 races (3 Saturday, 3 Sunday) with 5 to count

The scheduled time for the warning signal for race 1 is 12.55

There will be a briefing on Saturday 18th September at 12.00 at the Race Office

The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing Instructions, and Supplementary Sailing Instructions which will be posted on the Official NoticeBoard located in the Race Office, and on the BSC web site.

Risk Statement

Rule 4 of the Racing Rules of Sailing states "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone"

Sailing is by nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

(a)	They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;	(d)	Their boat is in good order, equipped to sail in the event and they are fit to participate;
		(e)	The provision of a Race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
(b)	They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;	(f)	The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
(c)	They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;	(g)	Their boat is adequately insured, with cover of at least £2,000,000 against third party claims;
